Addendum to Behaviour Policy in response to Covid-19

Fawbert and Barnard's Primary School has reviewed Annex A (Behaviour Principles) of the Planning Guidance for Primary Schools issued by the Department of Education.

Context

We want our school communities to feel safe, calm and re-assured, within an environment that is and feels physically and emotionally safe for all of us.

As the children return, we want them to feel excited and happy about coming into school. We want them to know that we are genuinely delighted to have them back and to be able to see them again. We will provide an inclusive environment, in which the children feel surrounded by support and know that they can rely on all the adults around them to be positively reinforcing the same messages, in order to create warm, welcoming feelings of care and nurture, when we cannot touch and need to keep a safe distance.

We will focus primarily on meeting the social and emotional needs of our pupils and on their readiness to learn skills.

This amendment is to be read in conjunction with our own published Behaviour and Discipline Policy. Staff will continue to follow this policy, in terms of promoting and rewarding positive behaviour, where possible and within the limitation of the COVID-19 secure school environment.

Many children and staff have experienced trauma and loss since the beginning of this current pandemic (COVID -19). There has also been significant loss of routine, structure, opportunities and freedom. This has significantly affected relationships, friendships and social interactions which, for some children and staff, could trigger a trauma response. The return to school for some of our children could also induce feelings of stress, due to the new routines and changed environment. Many may have experienced separation anxiety, due to the prolonged period at home with their parents. All staff in school need to be aware of this and adapt their responses accordingly. We will need to constantly model and coach around these new expectations, behaviours and routines; always reassuring and reframing any negative perceptions.

We know that all behaviour is communication and when we are seeing behaviours indicative of a stress/trauma response (such as increased irritability, activity, hyper-vigilance, withdrawal, non-compliance and all attention seeking behaviours), we should use positive, de-escalation techniques to acknowledge and validate the feelings and behaviours we are seeing and the possible reasons for those. Staff should then seek to reframe and reinforce the positive behaviours we wish to see, leading by example at all times.

Complex and unsafe behaviours

Challenging, complex and unsafe behaviours ("behaviours of concern") are an indicator that children need support to be included within our school provision. Complex and unsafe behaviours involve a very small proportion of children.

As some of the strategies we use for de-escalation and to support positive behaviour cannot be

used in the current circumstances (COVID -19), an individual risk assessment will be made for a child where the risk of complex unsafe behaviour is likely.

Such unsafe behaviours include:

- Spitting, licking and biting
- Physical aggression involving skin to skin contact
- Absconding
- Serious emotional distress caused by the need to maintain social distancing

This may include pupils:

- who have an individual behaviour or communication plan
- where the school deems it to be necessary due to behaviour of the pupil before the COVID-19 pandemic.

The risk assessment will be discussed and agreed with parents prior to returning to school. Where it is deemed that a child is too high a risk to come into school and keep themselves and others safe, the school will work with the parents and child to support a gradual transition into school at an appropriate time, when routines have been established at school. It is important to note that children's engagement in behaviours of concern can change over time.

Reasonable Adjustments

Please be aware that the following reasonable adjustments have been made in addition to our Behaviour Policy and will take effect from June 8th, 2020 until the end of this academic year.

All staff are expected to teach and model the new behaviour expectations, using the deescalation techniques and to support positive behaviour in line with our stated principles.

If pupils display any of the behaviours identified in the table on the following page, Parents / Carers will be contacted and the provision and approach will be discussed. Where we are unable to reduce the impact and risk of the behaviour, the indicated sanction will be used.

Parent/Carer agreement

In returning your child to school Parents/Carers are confirming that:

- they have read the school's Behaviour policy and this amendment which comes into effect from the 8th June 2020
- they understand that if their child displays the behaviours detailed in the amendment then they will be contacted and, where the school is unable to reduce the impact and risk of the behaviour, the indicated sanction will be used
- they will be fully supportive of these reasonable adjustments, which have been made to protect the pupils and staff at the school

Annex A: Behaviour principles

In light of the need for children to behave differently when they return to school, and any new systems you have put in place to support that, you'll need to make changes to your behaviour policy. Behaviour policy changes will also need to be communicated to pupils, parents and staff.

Areas schools may wish to add to their behaviour policy are:

- following any altered routines for arrival or departure
- following school instructions on hygiene, such as handwashing and sanitising
- following instructions on who pupils can socialise with at school
- moving around the school as per specific instructions (for example, one-way systems, out of bounds areas, queuing)
- expectations about sneezing, coughing, tissues and disposal ('catch it, bin it, kill it') and avoiding touching your mouth, nose and eyes with hands
- tell an adult if you are experiencing symptoms of coronavirus
- rules about sharing any equipment or other items including drinking bottles
- amended expectations about breaks or play times, including where children may or may not play
- use of toilets
- clear rules about coughing or spitting at or towards any other person
- clear rules for pupils at home about conduct in relation to remote education
- · rewards and sanction system where appropriate
- identify any reasonable adjustments that need to be made for students with more challenging behaviour.
