

TEMPLEFIELDS MULTI-ACADEMY TRUST SCHEME OF DELEGATION

Revised October 2022

The phrases used in the context of this document have the following meanings:

Consult: The individual or group who should be consulted by the Trustees as part of the process of completing the task.

Implement Develop:

The individual or group that has responsibility for undertaking the particular task delegated to them and reporting on its delivery as appropriate. In the case of the CEO, this will be at Trust level. In the case of the Headteacher, this will be at Local Governing Body

level.

Monitor: The group that has responsibility for monitoring whether a particular task is carried out to a satisfactory standard.

Recommend Propose:

The individual or group that should make recommendations/proposals as to how a particular task should be completed. The CEO, Finance, Audit, Personnel and Pay (FAPP) Committee and Local Governing Bodies (in relation to their own academy) will make

recommendations/proposals to the Trust Board. The Headteacher will make recommendations/proposals to their Local Governing

Body, and/or the CEO as appropriate.

Approve: Final approval of policies or recommendations made by the CEO or appropriate group to either the Trust board or Local Governing

Bodies (in cases where powers have been delegated to the Local Governing Body by the Trust Board).

Governor Monitoring: The key areas for monitoring identified by the Trust Board are Safeguarding, SEND, disadvantaged pupils (includes Pupil Premium) Curriculum (includes Teaching and Learning/standards) and professional learning and wellbeing. Local governing bodies must monitor these areas and provide reports to the relevant Local Governing Body. Local governing bodies may choose to monitor additional areas but in doing so must take into account the workloads of governors, staff and the headteacher.
